IN THE MATTER OF THE CANCELLATION
OF A CONTRACT WITH ERSKINE DELOE

ORDER No. 90-107

WHEREAS, Erskine Deloe made and entered into an agreement with Klamath County on January 4, 1989 for the purchase of E2NEW4SE4, TOWNSHIP 35, RANGE 10.0, SECTION 25, tax lot number R3510-02500-01700, for the sum of One Thousand Dollars (\$1,000.00), with the sum of Two Hundred Fifty Dollars (\$250.00) being paid as the first payment due on the contract; and

WHEREAS, in December of 1989, the Property Control Assistant mailed to Erskine Deloe at his address a letter requesting that the taxes be paid current on the property along with what was owed as per the contract dated January 4, 1989 within ten days of the date of that letter; and

WHEREAS, no payment has been made and the contract is now in default;

NOW, THEREFORE, IT IS HEREBY ORDERED that the Contract between Klamath County and Erskine Deloe dated January 4, 1989 is hereby cancelled. A certified copy of this Order shall be mailed by Registered Mail, Return Receipt Requested, to Erskine Deloe at his last known address.

NOTE: YOU HAVE TO RIGHT TO APPEAL, WITHIN TWENTY (20) DAYS OF THE SERVICE OF THIS ORDER OF CANCELLATION, THIS ORDER TO THE KLAMATH COUNTY CIRCUIT COURT PURSUANT TO ORS 275.220. FAILURE TO APPEAL WITHIN THE TIME FRAME PROVIDED SHALL TERMINATE ALL OF YOUR RIGHTS IN THIS PROPERTY.
