## CREATION OF PRIVATE ROAD EASEMENT

KNOW ALL MEN BY THESE PRESENTS, that HARRY L. OREM and GARY D. OREM, Initial Trustees of the S-H Trust UTA 9/18/88 (S-H Trust), in consideration of the approval of KLAMATH COUNTY, a Municipal corporation, of Major Land Partition 13-89 of the hereinafter described real property, and in consideration of the benefits accruing to the above named by reason of said approved Major Land Partition 13-89, do hereby irrevocably create the following described non-exclusive easement to be appurtenant to the respective partitioned parcel, with the rights and obligations hereinafter contained to run with the title to said parcels.

Parcel 2: A tract of land situated in the SW½ of Section 8, Township 41 South, Range 11 East, Willamette Meridian, Klamath County, Oregon, more particularly described as follows: Beginning at a point from which the Southwest corner of said Section 8 bears S. 72°35'46" W. 1611.24 feet; thence N. 17°38'16" E. 171.65 feet; thence N. 44°33'49" W. 132.52 feet; thence N. 86°06'37" W. 198.66 feet; thence S. 79°37'57" W. 175 feet, more or less, to the mean high water line of Lost River; thence Southerly, along said mean high water line, 270 feet, more or less, to a point that bears S. 87°56'26" W. from the point of beginning; thence N. 87°56'26" E. 334 feet, more or less, to the point of beginning, containing 2.4 acres, more or less, and with bearings based on a solar observation.

The easement hereby created shall provide ingress and egress over and across the following:

A 30-foot road easement situated in Sections 8 and 17, Township 41 South, Range 11 East, Willamette Meridian, Klamath

County, Oregon, more particularly described as follows:
