That portion of the Northeast Quarter of the Southeast Quarter of Section 26, Township 23 South, Range 9 East, W.M., described as follows: Beginning at the Southwest corner of the Northeast Quarter of the Southeast Quarter; thence East a distance of 550 feet; thence North 200 feet; which is the point of beginning; thence North a distance of 200 feet; thence East a distance of 550 feet; thence South a distance of approximately 100 feet to the intersection of The Dalles-California Highway right-of-way; thence Southwesterly approximately 125 feet along The Dalles-California Highway right-of-way; thence West a distance of approximately 475 feet, to the point of beginning, being pentagram in shape, all in Klamath County, State of Oregon.

AND that portion of the Northeast Quarter of the Southeast Quarter of Section 26, Township 23 South, Range 9 East, W.M., described as follows: Beginning at the Southwest corner of the Northeast Quarter of the Southeast Quarter; thence East a distance of 550 feet; which is the point of beginning; thence North a distance of 200 feet; thence East a distance of approximately 475 feet to the West line of the Dalles-California right-of-way; thence Southwesterly along said Highway a distance of approximately 250 feet to the South line of the Northeast Quarter of the Southeast Quarter; thence West approximately 390 feet which is the point of beginning.
