DECREE OF DISSOLUTION  
OF MARRIAGE

8 THIS MATTER came on for hearing this date; the Petitioner appearing  
9 in person and through her attorney, Daniel C. Dziuba and the Respondent  
10 appearing not and his default having been entered herein and the Court  
11 having considered said evidence, announced its opinion in open court and  
12 there being no request for Findings and Conclusions, and the Petitioner has  
13 proved that there have been irreconcilable differences between the parties  
14 hereto leading to the irremediable breakdown in the marriage, and that  
15 there is on file herein an Affidavit by the Petitioner that Respondent is  
16 not a member of the Armed Forces of the United States of America, and  
17 Petitioner desires a dissolution of the marriage; now, therefore,

18 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the marriage contract  
19 now subsisting between Petitioner and Respondent is hereby terminated and  
20 dissolved, that this Decree of Dissolution between Petitioner and Respond-  
21 ent becomes finally effective to dissolve and terminate the marriage status  
22 of the parties on the expiration of sixty days from the date hereof, to wit  
23 *31 May*, 1976, or, if an appeal is taken, on the date on which  
24 the suit is determined on such appeal, whichever is later, in case either  
25 party dies within the sixty day period specified above this Decree of  
26 Dissolution shall be considered to have entirely terminated the marriage

1 relationship of the parties immediately before such death unless an  
2 appeal is pending as aforesaid, and,

3 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that any time prior to the  
4 ~~Feb 31~~ day of May, 1976, or while an appeal is pending from this  
5 Decree, the Court may set aside this Dissolution of Marriage upon the motion  
6 of both parties, and,

7 IT FURTHER APPEARING that Petitioner resides at 1136½ High Street,  
8 Klamath Falls, Oregon; Petitioner's age is 19 years; petitioner's Social  
9 Security number is 542-72-3401; Petitioner's maiden name is Bowers, and,

10 IT FURTHER APPEARING that Respondent resides at 5305 Cottage, Klamath  
11 Falls, Oregon; Respondent's age is 34 years; Respondent's Social Security  
12 number is 541-45-7179, and,

13 IT FURTHER APPEARING that there has been born the issue of this marriage  
14 one child, to wit: Cassandra Lynn Coon, born September 16th, 1974, and,

15 IT FURTHER APPEARING that the parties were married on the 5th day of  
16 January, 1974 at Klamath Falls, Oregon;

17 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that;

18 1. Petitioner is awarded the future care, custody and control of the  
19 minor child of the parties subject to the guardianship of the court.

20 2. Respondent may visit said child at such reasonable times and places  
21 as will not interfere with her health, education and welfare;

22 3. Respondent is required to pay into the clerk if this court the sum of  
23 \$75.00 per month for the maintenance and support of the minor child of the  
24 parties until such time as the child reaches her majority or becomes emanci-  
25 pated;

26 4. Petitioner is awarded her personal belongings and effects now in her

- 1 control free and clear of any interest of the Respondent;  
2 5. Respondent is awarded his personal belongings and effects now in his  
3 control free and clear of any interest of the Petitioner;  
4 6. Respondent is required to pay the sum of \$2,685.74 now owing Dugan  
5 Chevrolet on a 1973 Ford LTD automobile which has been repossessed holding  
6 Petitioner harmless therefrom;  
7 7. Petitioner is awarded her maiden name of Bowers and her name is  
8 hereby changed to Bowers;  
9 8. Respondent is required to pay into the clerk of this court all fees  
10 and costs incurred in this suit.
