A tract of land situated in the NW1/4 of SW1/4 Section 20, Township 38 South, Range 9, East of the Willamette Meridian. Beginning at the intersection of the East line of the NW1/4 of SW1/4 and the North right of way line of the Southern Pacific Railroad Right of Way; thence North along said East line to the NE corner of the NW1/4 of SW1/4; thence West along the North line of said NW1/4 to the centerline of the West side By Pass as now located, thence Southerly along said centerline to the Northerly Right of Way line of aforementioned Railroad, thence Southeasterly along said Northerly line to the point of beginning. EXCEPT therefrom any portion of the above property conveyed to Klamath County and the State of Oregon for highway purposes. FURTHER EXCEPTING the following tract:
