This Satisfaction of Judgment is given to totally satisfy the judgments in my favor as follows:

- 1) Payment of the sum of \$250.00 per month commencing January 1, 1988 and continuing until the child attains the age of 18 or otherwise become emancipated or if said child is a child attending school as defined in ORS 107.108 until said child is no longer a child attending school or until said child attains age 21, whichever is earlier.
