Lot 2, Block 22, First Addition to Bonanza, Oregon

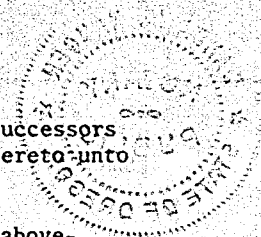
ACKNOWLEDGMENT FOR OREGON

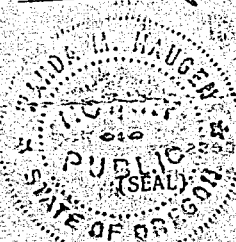
