KNOW ALL MEN BY THESE PRESENTS, That Larry King, hereinafter called grantor,

for the consideration hereinafter stated, does hereby remise, release and quitclaim unto

Ed Clough

hereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

A tract of land situated in the SW $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 6, Township 39 South, Range 10 East of the Willamette Meridian, in the County of Klamath, State of Oregon, more particularly described as follows: Beginning at the Northeast corner of the SW $\frac{1}{4}$ SE $\frac{1}{4}$  of said Section 6; thence South 89°46'35" West along the North line of said SW $\frac{1}{4}$ SE $\frac{1}{4}$  755.00 feet; thence South 00°04'39" East 977.24 feet, more or less, to a line which is North 00°04'39" West 350 feet from the Southerly line of the said SW $\frac{1}{4}$ SE $\frac{1}{4}$ ; thence North 89°45'36" East parallel to said Southerly line 374.22 feet, more or less, to the centerline of the Enterprise Irrigation District Canal and Northeasterly and Southeasterly along said centerline to the East line of the said SW $\frac{1}{4}$ SE $\frac{1}{4}$ ; thence North 00°04'39" West 932.02 feet to the point of beginning, TOGETHER WITH a 30 foot easement along the Easterly line of the SW $\frac{1}{4}$ SE $\frac{1}{4}$  of said Section 6, from the Southerly line of said SW $\frac{1}{4}$ SE $\frac{1}{4}$  to the centerline of the Enterprise Irrigation District Canal, for ingress and egress to the above described tract of land, EXCEPTING THEREFROM a tract of land more particularly described as follows: Beginning at a 5/8 inch iron pin from which the Northeast corner of said SW $\frac{1}{4}$ SE $\frac{1}{4}$  bears North 00°04'39" West 641.65 feet and North 89°46'35" East 755.00 feet; thence South 00°04'39" East 335.59 feet to a 5/8 inch iron pin on a line which is North 00°04'39" West 350 feet from the Southerly line of said SW $\frac{1}{4}$ SE $\frac{1}{4}$ ; thence North 89°45'36" East, parallel to said Southerly line, 245.00 feet to a 5/8 inch iron pin; thence North 00°04'39" West 335.59 feet to a 5/8 inch iron pin; thence South 89°45'36" West 245.00 feet to the point of beginning, with bearings based on a solar observation.
