STATE OF OREGON, acting by and through its DEPARTMENT OF TRANSPORTATION, Aeronautics Division, Grantor, conveys unto the STATE OF OREGON, by and through its DEPARTMENT OF TRANSPORTATION, Highway Division, Grantee, fee title to the following described property:

A parcel of land lying in the E½ of Section 33, Township 34 South, Range 7 East, W.M., Klamath County, Oregon and being a portion of that property described in that deed to the State of Oregon, by and through its Department of Transportation, Aeronautics Division, recorded in Book M-81, Page 2396 of Klamath County Record of Deeds and in that deed to the State of Oregon, by and through its State Board of Aeronautics, recorded June 24, 1960 in Book 322, Page 239 of Klamath County Record of Deeds; the said parcel being that portion of said property included in a strip of land variable in width, lying on the Easterly side of the center line of the relocated The Dalles-California Highway which center line is described as follows:

Beginning at Engineer's center line Station 3053+78.63, said station being 511.58 feet North and 803.30 feet West of the Southeast corner of Section 28, Township 34 South, Range 7 East, W.M.; thence South 6° 29' 28" West 7321.37 feet to Engineer's center line Station 3127+00.

The widths in feet of the strip of land above referred to are as follows:
