Stocking for pasture shall be adequate for the area but will be reduced or eliminated for hay growth and to avoid over grezing the area. Rotation grazing may be used where interior fences permit. Existing fences will be maintained by the lessee. irrigation will be accomplished with a wheel line and hand lines which will be furnished by the lessor. Lessee will keep these in good repair and protect them from livestock damage. Lessee will maintain minor maintenance of the buried mainline as needed. Lessee shall be responsible for lubrication of the pump. If serious deterioration of the mainline or pump should occur this will be addressed with negotation with the lessor or possible abandonment of irrigation or substitution of method or equipment.by lessee.
