That Mr. McDonald died on July 25, 1979. That after his death it was learned that his true name was Angus Leon McDonald.

That I know that the Angus Leon McDonald, whose estate was probated in Lane County, Oregon, Case No. 50-79-07513, was the same individual as the J. A. McDonald who once owned the real property described on Exhibit "A" attached hereto, and who sold the real property to Jerry D. Hargrave and Eileen E. Hargrave.

I have examined the files in the Klamath County Courthouse in cases DC 79-941L, DC80-576L and 82-379L, wherein an individual named James A. McDonald was the defendant. That James A. McDonald was served with summons in all of these cases after J. A. McDonald had died and I know that he cannot be the same individual. That J. A. McDonald was never known as James A.
