





ATTORNEY FEE AGREEMENT

ENVER BOZGOZ, agrees to defend, Kenneth E. Free on the charges of Burglary in the Second Degree; Theft in the First Degree by Possession - Count II, Burglary in the Second Degree; Theft in the First Degree by Possession - Count II and Burglary in the Second Degree ; Theft in the First Degree - Count II pending in the Circuit Court of the State of Oregon for the County of Klamath for a fee of Five Thousand (\$5,000.00) Dollars, to be paid out the proceeds of the sale of the client's residence, plus "out-of-pocket" expenses (such as investigative, expert witness, medical and transcript fees.) If the case is settled without going to trial, the fee will be Twenty Five Hundred (\$2,500.00) .
