....., hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of.....Klamath..... and State of Oregon, described as follows, to-wit:

A parcel of land situated in Lot 2, Section 31, Township 37 South, Range 9 E. W. M., in the County of Klamath, State of Oregon, known as Tract No. 7, and being more particularly described as follows:

Beginning at a point North 89°49' West 1444.55 feet from the quarter corner common to Sections 31 and 32, Township 37 South, Range 9 E. W. M., and running thence North 1°10' South 620 feet to a point being the true point of beginning of this description; thence North 89°49' West 582 feet, more or less, to the Easterly boundary of the Dalles-California Highway; thence North 2°50' East along the Easterly boundary of said Dalles-California Highway 100.63 feet, to a point; thence South 89°49' East 566 feet, more or less, to a point North 1°10' East 100 feet from the point of beginning; thence South 1°10' West 100 feet to the point of beginning.
