SUBORDINATION OF MORTGAGE

PARTIES: UNITED STATES OF AMERICA,  
Small Business Administration

(SBA)

(SVSB)

RECITALS:

A. SVSB obtained a judgment in Klamath County Circuit Court Case No. 87-114 CV in its favor against Donavin Ray Stonehill and Joanne Stonehill, husband and wife, hereinafter Stonehill, which judgment was entered January 5, 1988 in the sum of \$101,705.49, plus interest, and further on April 19, 1988, in the sum of \$15,990.29, plus interest.

B. By document dated February 1, 1989, SVSB assigned to SBA all of SVSB's interest in said judgment against Stonehill.

C. SVSB entered into loan transactions with Stonehill as follows:

Loan No. 203464, dated December 20, 1988, in the sum of \$41,600.00 plus interest, and

Loan No. 203465, dated December 20, 1988, in the sum of \$11,440.00 plus interest.

The above-referenced loans are secured by a Deed of Trust dated December 19, 1988, recorded in Klamath County Deed Records Volume M89-145, wherein Stonehill were grantors, William P. Brandsness is Trustee, and SVSB is the beneficiary.

D. It was the intent of the loan transactions to pay off a portion of the judgment owed to SVSB, and further, that the assignment by SVSB to SBA of the judgment aforementioned was not intended to grant SBA a superior interest in the real property subject to the aforementioned Deed of Trust. The parties to this agreement intend to subordinate the interest of the SBA to the interest of SVSB in that certain real property described as:

Lot 7, Block 1, CYPRESS VILLA, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

SUBORDINATION

For valuable consideration received, the SBA hereby subordinates its interest in the real property through the judgment lien, to the Trust Deed dated December 19, 1988 in favor of South Valley State Bank, upon the following described real property situated in Klamath County, Oregon, to-wit:

Lot 7, Block 1, CYPRESS VILLA, according to the official

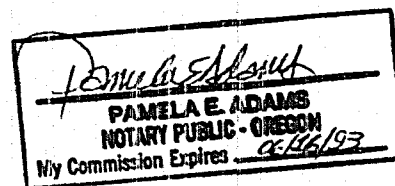
