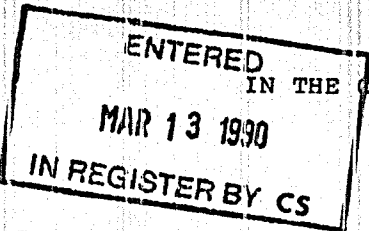

3 distribution has been filed herein.


4 IT IS ORDERED AND DECREED:

12 vested in said persons.

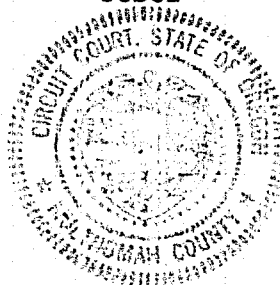

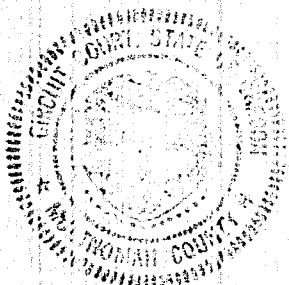
ORDER OF DISCHARGE


