

## TELEPHONE LINE RIGHT-OF-WAY EASEMENT

Lots 1, 2, 3 and 4 in Block 6 of IDLEREST, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon. Said facilities to be placed along and adjacent to the Easterly boundary of a Northerly-Southerly roadway, as it exists, located along and adjacent to the Easterly boundary of said described property.

Situated in the County of Klamath, State of Oregon. It is agreed that the Company, its successors and assigns, shall have access to said premises for the purposes stated, and shall be responsible for any damage to said premises by reason of any negligence on the part of said Company's employees while placing and maintaining construction.

This grant of easement is in no way intended to acknowledge the legal existence of the aforesaid Northerly-Southerly roadway.

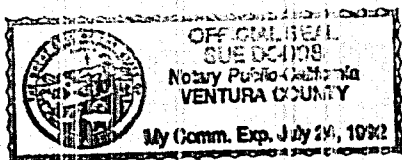

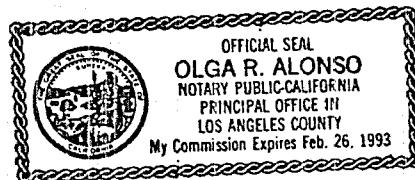
