TELEPHONE LINE RIGHT-OF-WAY EASEMENT

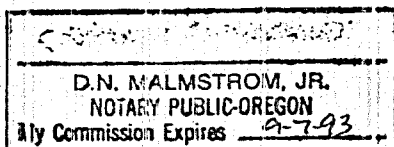

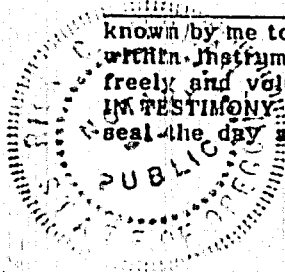
