AN ORDINANCE VACATING A PORTION OF OMAR STREET  
LOCATED WITHIN THE MOUNTAIN VIEW SUBDIVISION

WHEREAS, the owners of the real property hereinafter described desire to vacate a portion of Omar Street, between Summit and Calhoun streets located within the Mountain View subdivision; and

WHEREAS, after notice having been duly given, the City Planning Commission held a public hearing on April 9, 1990 on said request; and

WHEREAS, the City Council hearing notice having been duly given, did hold a hearing on May 21, 1990, on the record of the Planning Commission on the request of the property owner; and

WHEREAS, pursuant to such record and hearing, the City Council has determined the street vacation to be in compliance with the Community Development Ordinance and the Comprehensive Plan; NOW THEREFORE,

THE CITY OF KLAMATH FALLS ORDAINS AS FOLLOWS:

Those portions of Omar Street located adjacent to Blocks 14 and 17, and 13 and 14 of the Mountain View subdivision as shown on the official plat thereof on file in the office of the County Clerk for Klamath County, Oregon, and according to the map attached hereto, and incorporated as Exhibit "A", are hereby vacated.

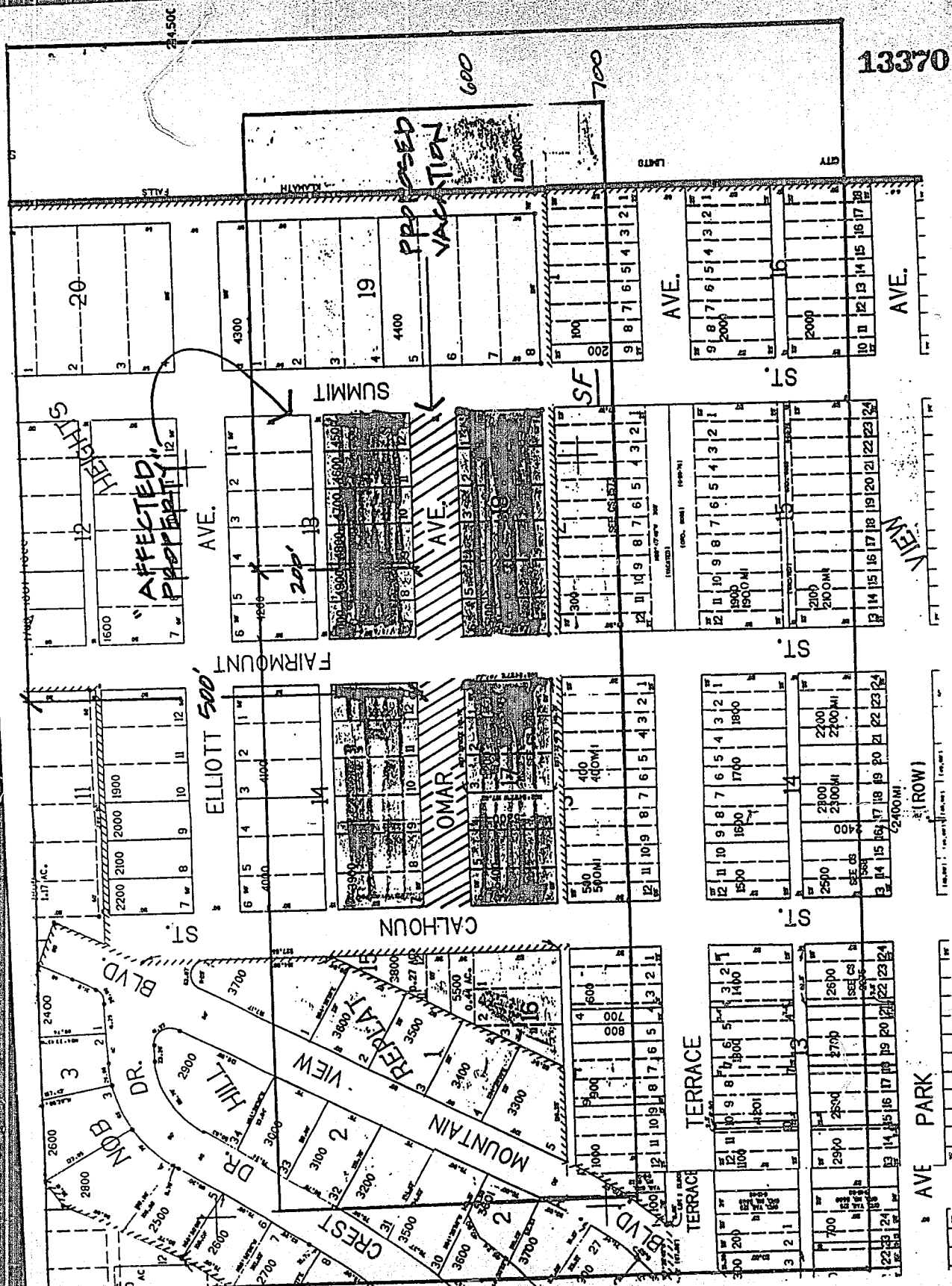
