

AN ORDINANCE VACATING A PORTION OF ALMOND STREET  
LOCATED IN THE CAMPUS VIEW SUBDIVISION

WHEREAS, the owners of the real property hereinafter described desire to vacate a portion of Almond Street located in the Campus View subdivision; and

WHEREAS, after notice having been duly given, the City Planning Commission held a public hearing on February 26, 1990 on said request; and

WHEREAS, the City Council hearing notice having been duly given, did hold a hearing on April 2, 1990, on the record of the Planning Commission on the request of the property owner; and

WHEREAS, pursuant to such record and hearing, the City Council has determined the street vacation to be in compliance with the Community Development Ordinance and the Comprehensive Plan; NOW THEREFORE,

THE CITY OF KLAMATH FALLS ORDAINS AS FOLLOWS:

That portion of Almond Street lying west of the northwesterly prolongation of the west property line common to Lots 2 and 3, Block 4, to its intersection with the northerly right of way line of Lot 2, Block 3, as indicated on the Campus View Subdivision Tract number 1163, sheet 2 of 2, found in the Klamath City records, Klamath County Oregon, to the west boundary of said subdivision, as shown on Exhibit "A" attached to and made a part hereof, is hereby vacated.

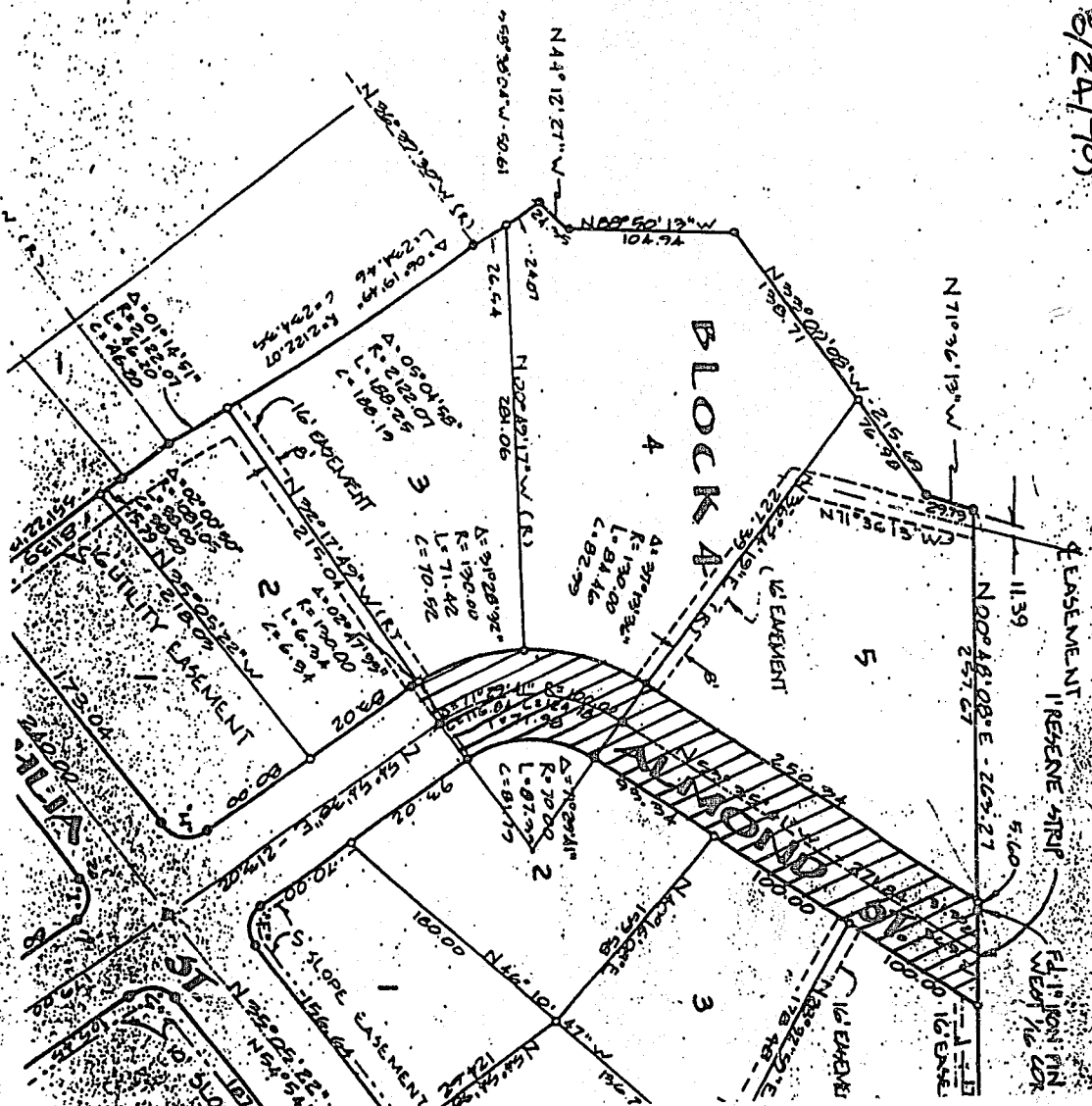
