Summershereinafter called grantor, for the consideration hereinafter stated, does hereby, grant, bargain, sell and convey unto Samuel H. Ferrill and Esther Ferrillhereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

The Southwest quarter of the Northwest quarter of the Northeast quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$ NE $\frac{1}{4}$) Section 12, Township 23 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, SUBJECT to an easement 30 feet in width for roadway purposes along the entire East West and South line of said parcel.

The Northwest quarter of the Northwest quarter of the Northeast quarter (NW $\frac{1}{4}$ NW $\frac{1}{4}$ NE $\frac{1}{4}$) of Section 12, Township 23 South, Range 9 East Of the Willamette Meridian, Klamath County, Oregon.
