NOTICE HEREBY IS GIVEN That Michael B. Wray claims a lien upon the following described animals: twenty (20) mixed breed commercial cattle raised and grown in the year 1990 upon the following described farmland, range, ranch, orchard land or in claimant's place of business situated in Klamath County, Oregon, to-wit:

N1/2SW1/4 of Section 5, Township 39 South, Range 9 East of the Willamette Meridian, SAVING AND EXCEPTING any portion lying within the USBR Irrigation Drain. ALSO SAVING AND EXCEPTING the West 1,760 feet of the North 600 feet, and the West 1,760 feet of the South 600 feet.

Said lien also is claimed upon the proceeds of the sale of any or all of said animals and upon the unborn progeny of said animals which are uteri on the date of the filing of this claim of lien. For brevity, the animals and/or their said unborn progeny charged with this lien hereinafter are called chattels.

Said lien is claimed for labor performed, materials supplied and/or services provided (as hereinafter more particularly described) by claimant at the request and for the benefit of the owner of said chattels to aid the raising of livestock upon the land described above; the words "performs labor or provides services," "materials," "growing and harvesting" and "raising animals" as used in this lien have the meaning ascribed to them in ORS 87226(3), to which reference hereby is made.

The said labor, materials and/or services consisted of pasturing.

The name of the owner of the chattels so charged with this lien is: John MacDonald.

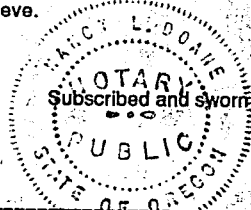
