NOTICE OF DEFAULT AND ELECTION TO SELL

Reference is made to a trust deed made by GUILLERMO VALENZUELA as grantors, to Klamath County Title Co. as trustee, in favor of Rose G. Young aka Rose J. Young, Edward C. Dore, and Jeanne M. Notice is further given that any person named in ORS 86.753 has the right, at any time prior to five days before the date last set for the sale, to have this foreclosure proceeding beneficiary of the entire amount then due (other than such portion of the principal as would not then be due had no default that is capable of being cured by tendering the performance required under the obligation or trust deed, and in addition to the default by paying said sums or tendering the performance necessary to cure enforcing the obligation and trust deed, and in addition to the default by paying all costs and expenses actually incurred in and attorneys fees not exceeding the amounts provided by said ORS 86.753.

In construing this notice, the masculine gender includes the feminine and the neuter, the singular includes the plural, the work "grantor" includes any successor in interest to the grantor of which is secured by said trust deed, and the words "trustee" and beneficiary" include their respective successors in interest.
