ELIZABETH LAURA OTTOMAN and SHIRLEY ANN MICKA, Personal Representatives of the estate of JAMES A. BUNNELL also known as J. A. BUNNELL and JAMES ALBERT BUNNELL, Deceased, grantor, conveys to ROBERT G. MICKA and SHIRLEY A. MICKA, husband and wife, grantee the following described real property located in Klamath County, Oregon, to-wit:
