WARRANTY DEED - TENANTS BY ENTIRETY

KNOW ALL MEN BY THESE PRESENTS, That RAYMOND T. SIENS, JR.  
and LARUE SIENS, husband and wife,  
hereinafter called the grantor, for the consideration hereinafter stated to the grantor paid by ROBERT A. DAUGHERTY and PHYLLIS M. DAUGHERTY, husband and wife, hereinafter called the grantees, does hereby grant, bargain, sell and convey unto the grantees, as tenants by the entirety, the heirs of the survivor and their assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:  
Lot 12 of ODESSA SUMMER HOME SITES, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.  
Subject, however, to the following:  
1. A 20 foot building setback from street as shown on dedicated plat.  
2. Restrictions and easements as contained in plat dedication, to wit:  
"Subject to setback lines of not less than 20 feet from street boundaries and an easement strip 10.0 feet in width with right of ingress and egress at the rear of all lots for public utilities."  
3. Agreement for regulating water level of Klamath Lake, including the terms and provisions thereof, between Herbert Fleishhacker, et ux, and the California Oregon Power Company, recorded February 15, 1924 in Book 63 at page 459, Deed records of Klamath County, Oregon.  
4. Covenants, conditions, restrictions and easements, but omitting

To Have and to Hold the above described and granted premises unto the said grantees, as tenants by the entirety, their heirs and assigns forever.

And grantor hereby covenants to and with grantees and the heirs of the survivor and their assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except as noted of record as of the date of this deed and those apparent upon the land, if any, as of the date of this deed;

grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$66,000.00.  
However, the actual consideration consists of or includes other property or value given or promised which is the whole or part of the consideration (indicate which). (The sentence between the symbols @, if not applicable, should be deleted. See ORS 93.030.)

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.
