Odedo made and entered into an agreement with Klamath County on July 22, 1987 for the purchase of OREGON PINES, LOT 28, BLOCK 17, tax lot number R3511-015AO-048000, for the sum of Six Hundred Twenty-six Dollars (\$626.00), with the sum of One Hundred Thirty-six Dollars and Sixteen Cents (\$136.16) being paid as the first payment due on the contract; and

WHEREAS, in March of 1989, the Property Control Assistant mailed to Oliver C. Odedo at his address a letter requesting that the taxes be paid current on the property along with what is owed as per the contract dated July 22, 1987 within ten days of the date of that letter; and

WHEREAS, no payment has been made and the contract is now in default;

NOW, THEREFORE, IT IS HEREBY ORDERED that the Contract between Klamath County and Oliver C. Odedo dated July 22, 1987 is hereby cancelled. A certified copy of this Order shall be mailed by Registered Mail, Return Receipt Requested, to Oliver C. Odedo at his last two (2) known addresses.
