ORDER No. 90-069

WHEREAS, Oliver C. Odedo made and entered into an agreement with Klamath County on July 22, 1987 for the purchase of PORTION WHITE LAKE CITY LOT 48 SECTION 16 TOWNSHIP 41 RANGE 10.0, tax lot number R4110-016AO-00500, for the sum of Nine Thousand Five Hundred Dollars (\$9,500.00), with the sum of Two Thousand Sixty-six Dollars and Twenty-five Cents (\$2,066.25) being paid as the first payment due on the contract; and

WHEREAS, in March of 1989, the Property Control Assistant mailed to Oliver C. Odedo at his address a letter requesting that the taxes be paid current on the property along with what is owed as per the contract dated July 22, 1987 within ten days of the date of that letter; and

WHEREAS, no payment has been made and the contract is now in default;

NOW, THEREFORE, IT IS HEREBY ORDERED that the Contract between Klamath County and Oliver C. Odedo dated July 22, 1987 is hereby cancelled. A certified copy of this Order shall be mailed by Registered Mail, Return Receipt Requested, to Oliver C. Odedo at his last known address.

NOTE: YOU HAVE TO RIGHT TO APPEAL, WITHIN TWENTY (20) DAYS OF THE SERVICE OF THIS ORDER OF CANCELLATION, THIS ORDER TO THE KLAMATH COUNTY CIRCUIT COURT PURSUANT TO ORS 275.220. FAILURE TO APPEAL WITHIN THE TIME FRAME PROVIDED SHALL TERMINATE ALL OF YOUR RIGHTS IN THIS PROPERTY.

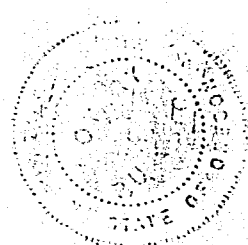
