RECONVEYANCE AND DEED OF RECONVEYANCE

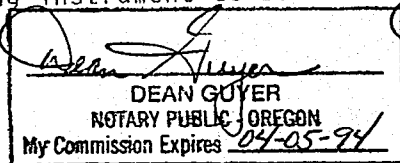

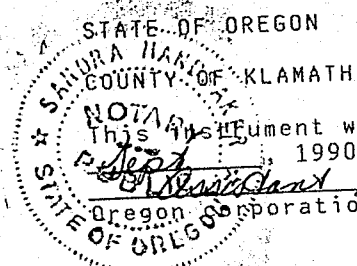

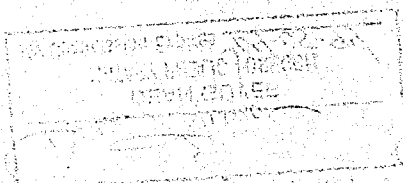
