This matter came before Neil D. Smith, Hearings officer for Klamath County, Oregon on 7 September 1990 in the County Commissioners' Hearing Room in Klamath Falls Dregon. The Klamath County Planning Department file and all the exhibits and other contents therein is incorporated by this reference into this matter.

## FINDINGS OF FACT.

Staff and the Applicant were in agreement that the use proposed is appropriate since it does not change the present use.

The condition precipitating this request was not caused by the applicant but rather by the widening of Summers Lane which reduced the present setback.

There was no testimony from any other party interested in opposition to this application even though adjoining property owners were given adequate notice for this hearing.

## ORDER .

NOW THEREFORE, the request of the petitioner is granted, there being no justification in any other action.

The applicant waives TO THE EXTENT OF THIS VARIANCE ONLY any condemnation rights in the event the public right-of-way is extended.
