## RECITALS

On or about June 11, 1979 Mortgagor made, executed and delivered to Bank her certain real property mortgage ("Mortgage") on and covering the real property situate in Klamath County, Oregon, and more particularly described in Exhibit A which is attached hereto and is by this reference incorporated herein. The Mortgage was recorded June 12, 1979 at Pages 13808 through and including Page 13810 in Volume M-79 of Mortgage Records of Klamath County, Oregon as document No. 68869. Mortgage was given to secure Mortgagor's promissory note ("Note") dated June 11, 1979 in the amount of \$35,000.00 maturing July 1, 1989.

## AGREEMENT

In consideration of the premises and of the promises and agreements hereinafter contained, Mortgagor and Bank agree:

Page 1 - MODIFICATION OF MORTGAGE AND ASSIGNMENT

The Mortgage and Assignment secure promissory note ("Note") dated September 28, 1990in the amount of \$35,000.00 together with interest thereon and any renewals, extensions or modifications thereof. The maturity date of the Note is September 10 , 1995. The Note evidences \$7,525.57 of new indebtedness and \$27,474.43 of old indebtedness.
- 2. Except as herein modified in the manner and on the terms and conditions hereinabove stated, the Mortgage shall be and remain in full force and effect, with all the terms and conditions of which Mortgagor does hereby agree to comply in the same manner and to the same extent as though the provisions thereof were in all respects incorporated herein and made a part of this agreement.
