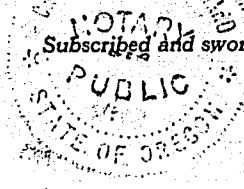

\* Federal law requires that not less than \$100 worth of labor must be performed or improvements made on a mining claim annually to hold the possessory right to the claim. The period within which the work is required to be done commences at 12:00 o'clock Meridian on the first day of September succeeding the date of location of the claim.

The applicable state law should be examined to determine all requirements for an Affidavit of Proof of Labor or Improvements and the time allowed for filing affidavits since requirements and time vary from state to state.

IMPORTANT NOTICE: A mining claim is deemed abandoned under 43 U.S. Code Sec. 1744 unless a copy of the official record of an affidavit of assessment work performed, a notice of intention to hold a mining claim, or a detailed report under 30 U.S. Code Sec. 28-1 is also filed annually for recordation with the state office of the Bureau of Land Management in the state where the claim is situated on or before December 30th of each year following the calendar year in which the claim was located. ## Geophysical Examination Report

## A. Nature, extent, and cost of the survey.

The nature of this geophysical survey was an examination of claim areas for relative isotopic readings of radioactive AU. The examination is of value not only for qualitative indications, but also for quantitative comparisons of one area of the deposit to another. The instrument is of the Algor scintillometer type and has been used extensively to find and evaluate mineral properties. The cost of the survey is indicated on the affidavit of proof of labor.

## B. Location of the work performed.

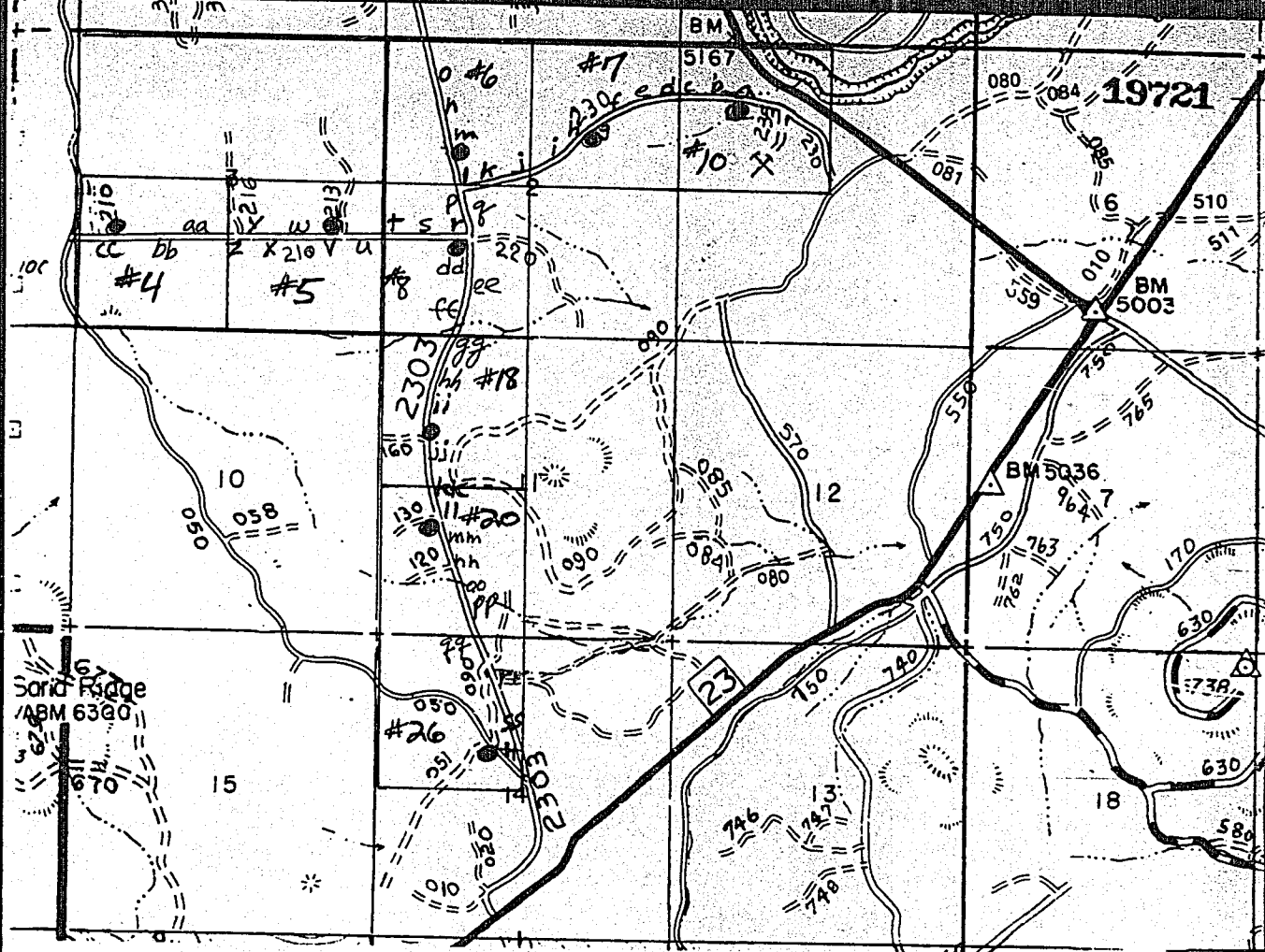
The locations where the readings were taken are depicted on the attached map. They can be seen in relation to the claims' borders and location monuments. When claims are contiguous, work performed on one or more claims applies to all.

## C. The survey examiner.

Jeffrey L. Hall has had extensive field experience with the instrument used and the interpretation of its readings. He has acted as a professional consultant to others using this instrument. Mr. Hall's address is: P.O. Box 17185, Salem, OR 97305.

## D. Interpretation of data.

Isotopic readings are stronger the higher the number. They indicate greater strength of mineralization the higher the number. However, P meter readings strengthen from N 100 to N 0 and continue from P 0 to P 100. Thus, P 10 is 50 points stronger than N 40.
