KNOW ALL MEN BY THESE PRESENTS, That **FIRST INTERSTATE BANK OF OREGON, N.A.** Trustee for the Ann J. Rife Trust, hereinafter called grantor, for the consideration hereinafter stated, doeth hereby grant, bargain, sell and convey unto **WILLIAM D. MCCABE and LINDA MCCABE, Husband and Wife**, hereinafter called grantees, and unto grantees' heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of **KLAMATH**, State of Oregon, described as follows, to-wit:

That portion of Lot 17, Block 38, HOY SPRINGS ADDITION TO THE CITY OF KLAMATH FALLS, OREGON, in the County of Klamath and State of Oregon, described as follows:
