**SPECIAL LIMITED POWER OF ATTORNEY**

The power conferred on my attorney in and by this instrument shall be exercisable from this date, notwithstanding a later disability or incapacity on my part, unless otherwise provided by the statutes of the State of Florida.

c) All acts done by my attorney in fact pursuant to the power conferred during any period of my disability or incompetence shall have the same effect and inure to the benefit of and bind me or my heirs, devisees, and personal representatives, as if I were competent and not disabled.

d) This specific limited power of attorney shall be nondelegable and shall be valid until such time as I shall revoke this power.


