EXHIBIT "A"

A track of land situated in the SE 1/4 SW 1/4 of Section 2, Township 39 South, Hange 9 East of the Willamette Meridian, in the County of Klamath, State of Oregon, more particularly described as follows:

Beginning at a 5/8" Rebar with a Tru-Line Surveying plastic cap on the Westerly right of way line of Hope Street, from which the South quarter corner of said Section 2 bears South 00 degrees 13' West 270.12 feet and North 89 degrees 36' 38" East 695.17 feet; thence North 60 degrees 51 West 264.00 feet to a 5/8" iron pin with a Tru line Surveying plastic cap; thence South 23 degrees 09' West 161.28 feet to a 5/8" Rebar with a Tru-Line Surveying plastic cap on the Northerly line of that Tract of land described in Volume 193 at Page 49 of the Klamath County and Described in Volume 193 at Page 49 of the Klamath County bearing the state of the South 66 degrees Deed Records; thence along said Northerly line South 66 degrees 51 East 281.20 feet to a 5/8" Rebar with a Tru-Line Surveying plastic cap and South 89 degrees 56' East 47.00 feet to a 5/8" Rebar with a Tru-Line Surveying plastic cap on the Westerly right of way line of Hope Street; thence North 00 degrees 13' East 155.12 feet to the point of beginning, with bearings based on the recorded survey of said Major Land Partition No. 29-88.
