

KNOW ALL MEN BY THESE PRESENTS, THAT RON MOORE AND LYNN SELDOMRIDGE, HEREINAFTER REFERRED TO AS "GRUBSTAKERS", HAVE AGREED TO GRUBSTAKE RAYMOND OSBORNE, KARIN OSBORNE, ROBERT ANDREWS, LINDA ANDREWS, LYNN SELDOMRIDGE, ALTA SELDOMRIDGE, LYNDA PACHECO, MELISSA A. MOORE, RON MOORE, MELINDA A. MOORE, AND HEREINAFTER REFERRED TO AS "CLAIMANTS".

FOR GRUBSTAKING THIS VENTURE THE GRUBSTAKERS & CLAIMANTS AGREE, THAT SIXTY-FIVE (65) PERCENT OF ALL ROYALTIES, SHARES, MONIES, AND OR PROFITS SHALL BE PAID TO THE GRUBSTAKERS WITHIN FIVE (5) DAYS OF RECEIPT THERE OF, THE BALANCE OF THE ROYALTIES, SHARES, MONIES, AND OR PROFITS SHALL THEN BE EQUALLY SHARED BY THE LISTED CLAIMANTS.

ALL GRUBSTAKE MONIES TO BE USED SHALL BE AGREED TO IN ADVANCE BY BOTH THE GRUBSTAKERS AND CLAIMANTS, AND THEN USED ONLY FOR THAT ACTUAL EXPENSE TO ATTAIN THESE PLACER CLAIMS AND FOR FILING ASSESSMENT WORK AS DEEMED NECESSARY.

THIS GRUBSTAKING AGREEMENT IS ALSO RESTRICTED TO ONLY THE CLAIMING AND DEVELOPMENT OF PLACER DEPOSITS IN ACCORDANCE WITH OREGON AND FEDERAL MINING REGULATIONS, AND THEN FURTHER RESTRICTED TO PLACER DEPOSITS IN TOWNSHIP 27S RANGE 6E OF THE WILLAMETTE MERIDIAN IN KLAMATH COUNTY, OREGON.

THIS AGREEMENT TAKES EFFECT THIS 2 DAY OF SEPT., 1990, AND SHALL REMAIN IN EFFECT AS LONG AS THE GRUBSTAKERS OR THEIR REPRESENTATIVES AGREE TO PAY THE MUTUALLY AGREED EXPENSES OF THE CLAIMANTS FOR THE BUCKEYE CLAIMS, NUMBERS 1 THRU 8.

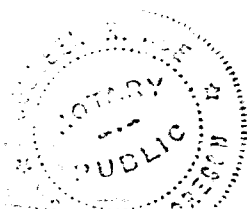
