KNOW ALL MEN BY THESE PRESENTS, That the undersigned, hereinafter called the assignor, for the consideration hereinafter stated, has sold and assigned and hereby does grant, bargain, sell, assign and set over unto Edward Zarosinski, D.M.D. Pension Profit Sharing & Trust hereinafter called the assignee, and to assignee's heirs, successors and assigns, all of the vendor's right, title and interest in and to that certain contract for the sale of real estate dated Sept. 1, 1983, between Edward R. Zarosinski and Thomas R.
