If, however, such monthly payments shall not be sufficient to pay such items when the same shall thirty (30) days after written notice from the Beneficiary as trustee any amount necessary to make up the deficiency within mail. If at any time Grantor shall tender to Beneficiary, stating the amount of the deficiency, which notice may be given by indebtedness secured hereby, Beneficiary as trustee with the provisions hereof, full payment of the entire Grantor any credit balance remaining under the provisions of (a) of paragraph 2 hereof.
