Friedman Kirk was the son of Seldon E. Kirk and Mary Hill Kirk. Seldon and Mary Kirk had three children; Raymond, Lelia and my nusband Friedman.

Raymond Kirk was the owner of allotment #1527 comprising a total of 20 acres received from the United States Department of Interior, Bureau of Indian Affairs more particularly described as:

SWl/4NEl/4SEl/4, Wl/2SEl/4NEl/4SEl/4, Wl/2NWl/4NEl/4 SEl/4 Section 12. Township 34 South, Range 71/2 East, W.M. Oregon

Raymond Kirk died on June 1, 1926 intestate and no probate has been had. Further, he died single and no children or children of deceased children survived him. Mary Hill Kirk died in December 1952.

307, page 373, deed records of Klamath County, Oregon, shows the owners of the above described property as follows: Seldon E. Kirk undivided 1/2 interest, Lelia Kirk undivided 1/4 interest and Friedman Kirk undivided 1/4 interest.

Seldon Kirk died June 21, 1971. A certificate of death was filed on January 4th, 1973 at Volume M73, page 900, deed records of Klamath County, Oregon. Seldon Kirk died intestate and his only remaining heirs were his son Friedman Kirk and his daughter Lelia Kirk.

Lelia Kirk died intestate on April 3, 1987 and a probate was completed in Deschutes County, State of Oregon, Circuit Court Case #37-PB-0045-JT. Her only heir in that probate is her son Raymond Kirk. The above mentioned property did not go through Lelia Kirk's Deschutes County probate as Raymond Kirk was not aware of his mother's interest in this property.

Therefore the remaining heirs of the undivided 1/2 interest of Seldon Kirk are myself, as the surviving heir of Friedman Kirk and Raymone Kirk as the sole surviving heir of Lelia Kirk, and each is entitled to 1/2 of Seldon Kirk's 1/2 undivided interest or undivided 1/4 interest in the above described property.
