11 The First Party does hereby grant to the Second Party, for so long as he
12 shall live, the right to obtain water from the well located on the First Party's
13 property for domestic purposes on Lot 17, Block 9, MIDLAND. The Second Party
14 shall maintain the distribution line from the well to the Second Party's pro-
perty. The First Party and Second Party shall share equally in the cost of
operating the well, including electricity to the pump and the cost of main-
taining the well.


15 This Agreement shall remain in full force and effect so long as A. L.


