WARRANTY DEED

Lot 4, Block 19, SECOND ADDITION TO KLAMATH RIVER ACRES, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

TOGETHER WITH: 1970 Fleetwood mobile home, serial #S10379 which is firmly affixed to this property.

SUBJECT TO: Trust Deed (including terms and provisions thereof), dated March 23, 1988, recorded March 25, 1988 in Volume M88, Page 4184, Microfilm Records of Klamath County, Oregon, wherein the Beneficiary is: Ray F. Moss and Denise Y. Moss, husband and wife. The above Grantee hereby agrees to assume and to pay this in full and to hold Seller harmless therefrom.

This instrument will not allow use of the property described in this instrument in violation of applicable land use laws and regulations. And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple and the above granted premises, free from all encumbrances except all those of record and those apparent to the land as of the date of this deed

grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances. The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 28,000.00.
