KNOW ALL MEN BY THESE PRESENTS, That WM. S. & Eilene Mardock

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by Larry E. & Suzanne L. Bowman

the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

That part of the NE 1/4 of the SE 1/4 of Section Twenty-Six (26), Township Twenty-Three (23) South, Range Nine (9), E.W.M., described as:

Beginning at the Northwest corner of the Northeast Quarter of the Southeast Quarter (NE 1/4 SE 1/4) thence Southerly along the Westerly boundary a distance of 715' feet to the true point of beginning; Thence East a distance of 550' feet; Thence South a distance of 175' feet; Thence West a distance of 550' feet; Thence North a distance of 175' feet to the point of beginning.

RESERVING HOWEVER, unto the grantor, his heirs and assigns, an easement over, upon and across the easterly 50 feet thereof,-----

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
