The above matter coming before this Court, upon motion of the
Petitioner, Louisa L. Horton, and the Court being fully advised
therein; and,

It appearing to the Court that on February 3, 1981, an Order
modifying the Decree of Dissolution reduced alimony to \$450.00 per
month effective October, 1980, until further order of the Court.
Said Order was recorded February 3, 1981, in Vol. M-81, Page 1608,
records of Klamath County, Oregon. The Court of Appeals of the
State of Oregon affirmed the aforesaid opinion, with the mandate
being filed in the Court of Appeals on July 24, 1985, and filed in
the Klamath County Circuit Court on November 14, 1985, with costs
of \$145.00 taxed against Appellant-Respondent, Robert L. Horton;
and,

A Stipulation was entered into on May 12, 1982, setting forth
the amounts owed Petitioner for alimony and property settlement,
and a Stipulated Judgment was executed on May 12, 1982, granting
Petitioner, Louisa L. Horton, judgment against Respondent, Robert
L. Horton, in the sum of \$14,100.00 due as of March 18, 1982, in

1 Alimony and \$20,257.73, plus 6½% interest from December 29, 1981,
2 until paid, for property settlement; said Stipulated Judgment was
3 filed in the Circuit Court Clerk on May 13, 1982, and recorded in
4 Vol. M-82, Page 7273 of Records of Klamath County, Oregon.
5

6 On November 10, 1982, the Property Settlement Judgment of
7 \$20,257.73, plus interest, was satisfied. On September 27, 1983,
8 the Alimony judgment of \$14,100.00 was satisfied. Remaining
9 unsatisfied were, and still are, the alimony payment of \$450.00
10 due October 16, 1983, and like payments of \$450.00 thereafter for
11 Alimony pursuant to the Court's prior Order dated February 3,
12 1981, which Order was continued in full force and effect in the
13 Stipulated Judgment dated May 12, 1982.

14 That, under Oregon marital law, support obligations accrue as
15 judgments monthly when they become due and the oldest judgment
16 currently on this case therefor being October 16, 1983, in the
17 amount of \$450.00 with a like of \$450.00 accruing each month since
18 that time; and,

19 That the period of ten (10) years since the entry of the
20 aforesaid judgments has not expired;

21 NOW, THEREFORE, on motion of Petitioner, by and through her
22 attorney, Karla J. Knieps, IT IS HEREBY ORDERED that the Judgments
23 dated February 3, 1981, by Order recorded in Vol. M-81, Page 1608,
24 and Stipulated Judgment dated May 12, 1982, recorded in Vol. M-82,
25 Page 7273, which Stipulated Judgment continued in force the prior
26 Order dated February 3, 1981, be renewed as to those alimony

1 payments which remain unsatisfied, to-wit:

2 \$450.00 per month from and including payment due October
3 16, 1983, and a like amount each month thereafter with
4 applicable statutory interest

5 and that a new entry of same be made in the Judgment Docket and
6 that after the entry of said judgment, the lien for all judgment
7 amounts of \$450.00 per month commencing with October 16, 1983,
8 forward shall continue for ten (10) years unless said Judgments
9 shall be sooner satisfied, and that execution may be made upon
10 said judgments.


