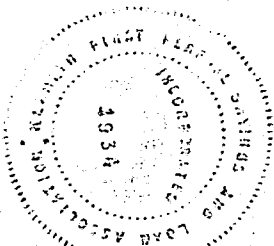
# SATISFACTION OF MORTGAGE

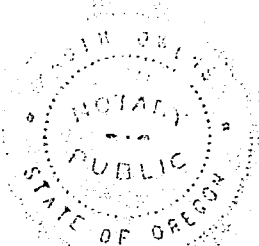
