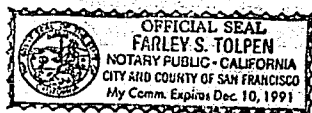

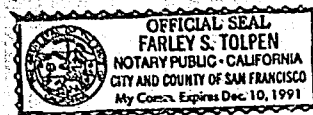

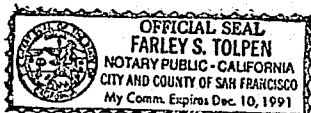

LAST WILL AND TESTAMENTOF

ROBERT H. LEWIS

I, ROBERT H. LEWIS, a resident of the City and County of San Francisco, California, being of full age, sound mind and memory and under no restraint, do make, publish and declare this instrument to be my last Will and Testament and hereby revoke all Wills and Codicils that I have previously made.

ARTICLE I

I hereby declare that I have never been married and have never had any children.

ARTICLE IIFUNERAL

At my demise, I request immediate cremation, with no embalment and no funeral. I request that my ashes be scattered over the Pacific Ocean, outside the Golden Gate Bridge. I am a veteran of World War II and therefore, I am entitled to burial benefits from the U.S. Government.

ARTICLE IIIDEBTS. TAXES AND EXPENSES

All my funeral, last illness, and administration expenses, as well as all death taxes and other lawful claims and charges against my estate, shall be paid out of the residue of my estate, subject, however, to the following:

2.1 Debts. The provisions of my Will shall not operate to in any way accelerate any liability and all indebtedness of mine for which any properties or insurance policies stand as collateral security shall remain an encumbrance upon the same which shall pass subject to such indebtedness without reimbursement of any kind from my estate.

2.2 Taxes. As used in my Will, the term "death tax" includes all estate, inheritance, succession, or other similar taxes (including any interest and penalties relating thereto, but

excluding all recapture taxes under Section 2032A of the Internal Revenue Code and all generation skipping taxes) which may be imposed upon my estate, any trust, or anyone incident to my death, regardless whether or not the property with respect to which such tax is levied passes through the hands of the Executor. Neither my Executor, nor anyone else shall require that any part of any such taxes be recovered from, paid by, or apportioned between the recipients or of those interested in any such property.

ARTICLE III

BEQUESTS

I give all of my cash or any interest thereof as follows:

ARTICLE V

NON-EXERCISE OF POWER OF APPOINTMENT

I refrain from exercising any testamentary power of appointment that I may have at the time of my death.

ARTICLE VI

WILL CONTEST PROVISION

If any beneficiary under this Will, in any manner, directly or indirectly, contests or attacks this Will or any of its provisions, any share or interest in my estate given to that contesting beneficiary under this Will is revoked and shall be disposed of in the same manner provided herein as if that contesting beneficiary had predeceased me without issue.

ARTICLE VII

EXECUTOR

I nominate JANET and SIGMOND FREEMAN as Co-Executors of this Will, to serve without bond. If either of them shall predecease me or for any reason fail to qualify or cease to act as Executor of this Will then I nominate the other party as Executor of this Will, to serve without bond.

I authorize my Executor to invest and reinvest any surplus money in the Executor's hands in every kind of property, real, personal, or mixed, and every kind of investment, specifically

including but not limited to interest-bearing accounts, corporate obligations of every kind, preferred or common stocks, shares of investment trusts, investment companies, mutual funds, or common trust funds, including funds administered by the executor, and mortgage participations, that men of prudence, discretion, and intelligence acquire for their own account.

I authorize my Executor to sell, with or without notice, at either private or public sale, and to lease any property belonging to my estate, subject only to such confirmation of the Court as may be required at law.

My Executor shall have absolute discretion, but shall not be required, to make adjustments in the rights of any beneficiaries, or among the principal and income accounts, to compensate for the consequences of any tax decision or election, or of any investment or administrative decision, that my Executor believes had the effect, directly or indirectly, of preferring one beneficiary or group of beneficiaries over others. In determining the federal estate and income tax liabilities of my estate, my Executor shall have the discretion to select the valuation date and to determine whether any or all of the allowable administration expenses in my estate shall be used as federal estate tax deductions or as federal income tax deductions.

I further authorize my Executor either to continue the operation of any business belonging to my estate for such time and in such manner as my Executor may deem advisable and for the best interests of my estate, or to sell or liquidate the business at such time and on such terms as my Executor may deem advisable and for the best interests of my estate. Any such operation, sale, or liquidation by my Executor, in good faith, shall be at the risk of my estate and without liability on the part of my Executor for any resulting losses.

ARTICLE VII

INVALID PROVISIONS

If any part, clause, provision or condition of this Will is held to be void, invalid or inoperative, I direct that such invalidity shall not affect any other part, clause, provision, or condition of this, my last Will and Testament, and that the remainder of this Will shall be carried into effect as though such part, clause, provision or condition had not been contained herein.


