Dean in foreclosure of a non-judicial 11 trust deed supported by the petition of William L. Sisemore, attorney for 12 beneficiaries of the trust deed, and the Court having considered the application 13 and the affidavit of William L. Sisemore, and it appearing to the Court that the 14 basis of the obligation of the Respondent Robert M. Dean was the trust deed executed by Robert M. Dean while he was on active duty with the military service and he is therefore not entitled to the benefits of the Soldiers' and Sailors' Civil Relief Act. 50 U.S.C. Sec 107. The Soldiers' and Sailors' Civil Relief Act. does not prohibit the foreclosure of a trust deed executed after the entry into the military service. Whitaker v. Hearnsberger, 123 Colo. 545, 233 P.2d 389; Brown v. Gerber 495 P2d 1160., and it further appearing to the Court that 50 U.S.C. 520 requires the Court to appoint an attorney to represent a member of the military service and the Court being fully advised of the premises, NOW, THEREFORE, it is hereby Ordered:

1. That Richard Belcher, a member of the Oregon State Bar is hereby appointed to represent the Respondent Robert M. Dean in the above-Order Appointing Attorney - Page 1.
