

## MEMORANDUM OF CONTRACT

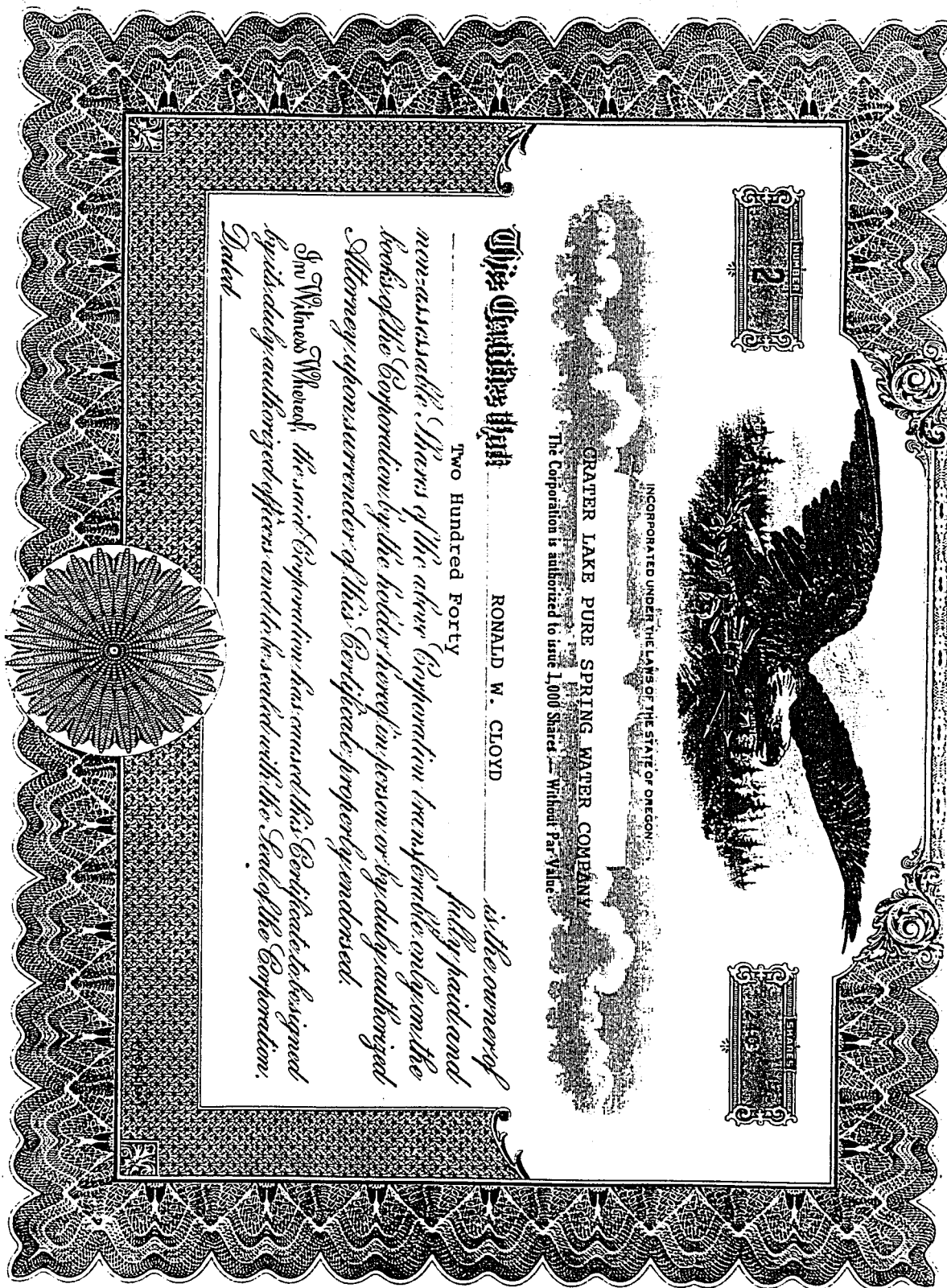
