

Seller under the Contract described below declares Purchaser is in default for the reasons set forth herein under ORS 93.905 through 93.945.

## 1. DESCRIPTION OF CONTRACT:

(A) PURCHASER: MICHAEL W. SHORT AND MARGERY L. SHORT

(B) SELLER: THE BANK OF CALIFORNIA, N.A., as Trustee

(C) CONTRACT RECORDED: 12-2-82, vol. M82, Page 16625, Deed of records of Klamath County, dated 10-19-81

(D) AMOUNT AND TERMS OF CONTRACT: \$6,600.00. \$700.00 down, balance of \$5,900.00 at \$84.66 per month starting 1-15-82 until paid including 12% interest per annum.

(E) PROPERTY COVERED BY CONTRACT: Lot 14 in Block 12, Mt. Scott Meadow, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

2. NATURE AND AMOUNT OF DEFAULT: Failure to pay: (A) 90.24 regular monthly payments at \$84.66 or a total of \$7,639.40. (B) Real property taxes in the sum of \$1,135.15 plus interest to date.

3. SUM OWING ON OBLIGATION: Principal balance of \$5,273.17 with interest at 12% percent per annum from 10-9-83, plus taxes, attorney fees, and foreclosure costs.

Unless the default is cured as set forth in paragraph 5 of this Notice, the Purchaser and all persons claiming through the Purchaser shall have no further rights in the contract or the property and no person shall have any right to redeem the property. All sums previously paid under the contract by or on behalf of the Purchaser shall belong to and be retained by the Seller or other person to whom paid under the terms of the contract.

Notice is given that forfeiture may be avoided under the Contract by curing the default(s) by payment of the entire amount due, other than such portion of principal as would not then be due had no default occurred, and tendering performance of other obligations in default, together with costs and expenses actually incurred in enforcing the contract on or before 7-10-91. 


