## 1. DESCRIPTION OF CONTRACT:

(A) PURCHASER: ROBERT W. RUSKA and CHERYL D. RUSKA

(B) SELLER: THE BANK OF CALIFORNIA, N.A., as Trustee

Unless the default is cured as set forth in paragraph 5 of this Notice, the Purchaser and all persons claiming through the Purchaser shall have no further rights in the contract or the property and no person shall have any right to redeem the property.
