THIS MATTER having come before the court for trial on the 28th day of March, 1991, with Ernestine Parrish Kirk appearing on behalf of plaintiff and by and through Michael L. Brant, attorney for plaintiff; and defendants appearing in person and by and through their attorney, Douglas V. Osborne, and the Court having heard the testimony of the parties and having received exhibits and having heard the arguments of counsel and being fully advised in the premises,

AND THE COURT HAVING FOUND THAT Ernestine Parrish Kirk was incompetent at the time she executed the Bargain and Sale Deed on July 6, 1971 and that Ernestine Parrish Kirk was under the complete domination and control of her father, Harol Parrish, and not exercising her free will at the time she executed the deed,

AND THE COURT FURTHER FINDING THAT Harol Parrish had not AMENDED JUDGMENT -1-

been discharged of his duties as Guardian for Ernestine Parrish, now Ernestine Parrish Kirk, when he arranged the deed and that subsequent to July 6, 1971, Harol Parrish was, again, appointed guardian and conservator for Ernestine Parrish and continued as such until his forced removal on December 31, 1985,

AND THE COURT FURTHER FINDING THAT Harol Parrish dominated Ernestine Parrish's life, treated her property as his own, and even went to jail rather than properly account to the court for his stewardship,

AND THE COURT FURTHER FINDING THAT the estoppel defense was not proven and the statute of limitations did not start to run until Harol Parrish's removal as guardian and conservator of Ernestine Parrish Kirk, now, therefore

IT IS HEREBY ORDERED AND ADJUDGED THAT that certain Bargain and Sale Deed dated July 6, 1971 and recorded in the Klamath County, Oregon deed records in Volume M 71 at Pages 11918 and 11919 wherein Ernestine Parrish was the Grantor and Harriet C. Parrish and Eulova Comeah Parrish were the Grantees is set aside, cancelled and of no further force nor effect; and

IT IS FURTHER ORDERED AND ADJUDGED THAT the interest which Ernestine Parrish, now Ernestine Parrish Kirk had in the property which is the subject of the Bargain and Sale Deed above described prior to July 6, 1971 is hereby restored to her as fully as though said Bargain and Sale Deed had never been executed; and

IT IS FURTHER ORDERED AND ADJUDGED THAT plaintiff is
