 shall apply equally to individuals and to corporations.

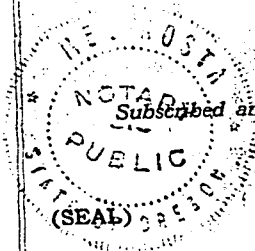
