

-QUITCLAIM DEED-

Harold A. Campbell, Grantor, releases and quitclaims to, Melvin L. Stewart and Mary Lou Stewart, husband and wife, Grantee, all right, title and interest in and to the following described real property:

That portion, if any, of the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 36, T38S, R9EWM, Klamath County, Oregon lying West of the following described line:

Beginning at the long accepted C-W 1/16 corner of said Section 36, from which the West $\frac{1}{4}$ corner of said Section 36 bears S89°58'32"W 1302.15 feet; Thence North 2640 feet, more or less, to a point on the North line of said Section 36 with bearings based on Tract 1152-- North Hills.

Excepting that portion deeded to the City of Klamath Falls by Deed Volume M85, page 20984 and El Paso Natural Gas Co. by Deed Volume 383, page 145.

The true and actual consideration for this conveyance is for purposes of adjusting the boundary line between the Grantor's property and the Grantee's property to a true North line. Grantee by acceptance of this deed waives any claims against Grantor related to the survey of the property or the establishment of the boundary.

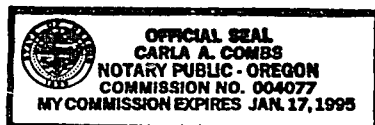
